Per WV Open Meetings Act Opinion 1999-08, it is the opinion of the WV Ethics Commission that allowing citizens to attend a meeting in person is <u>not required</u> if the governing body determines, based upon guidance issued by the Federal Government, the State of West Virginia, the Centers for Disease Control and Prevention or other government agencies authorized to make these types of decisions, <u>that it constitutes a public health risk to allow citizens to attend in person</u>.
