BUDGET REVISIONS

Commissioner Epling moved to approve Sheriff's budget revision in the amount of \$61,513.02 for reimbursement of overtime fees. Seconded by Commissioner Duckworth and motion carried unanimously. (SEE EXHIBIT D)

Commissioner Tolliver stated each Deputy Sheriff will receive a \$5,000.00 raise and each County Employee receive a 5% salary increase for each County employee, effective immediately.


